UCF has a membership of over 40 and above who finance, trade, export and process over 95% of Uganda's coffee. Our membership includes producers, exporters, cooperatives, roasters and allied members such as consultancy, logistics and training support. Our national contribution is 95% of Export Value (\$900m), the bulk of Cess (2% of total exports value) paid for research & government sector interventions and the bulk of taxes paid within the sector.
